
Description

The ALL-PS103G-BT60-PD is powered via PoE, so no additional power supply is required. Simply connect the input of the splitter to a PoE switch or PoE injector and the output side to a non-PoE Type-C PD network device such as access points, computers, Ipads, notebooks, etc. to provide power and data. The charge output voltage automatically adjusts to 5VDC / 9VDC / 12VDC / 15VDC / 20VDC if the connected end device also meets the standard. So this splitter can extend your network if you want to place network devices in places where there are no electrical outlets available.
